## RULES AND REGULATIONS & ASSOCIATION

1. NAME OF THE SOCIETY : Name of the society shall be:-

5. GENERAL BODY DEFINED: All the members of the society will constitute the General Body of the society.

### 6. GENERAL BODY:

- a) Notice: Minimum '10' days notice shall be given to the members, before the date of General Body meetings, enclosing agenda specifying date, time, place and issue s to be discussed.
- b) Meeting: General Body meeting shall be held once in every year regularly.
